1. WELCOME

Meeting opened at 18:15. Meeting was chaired by Peter **Coad** as Cllr **Anissee** sent his apologies. Peter **Coad** introduced Julie **Ryland** from Hornsby Shire Council now acting as the Natural Resources Strategy Manager. Julie is now overseeing the Estuary Program at Hornsby Shire Council. Peter **Coad** is now the manager of the Natural Resources Branch. Peter **Coad** also introduced Michael **Hourn** who is filling in temporarily for Warren **Brown** at Gosford City Council. Finally Peter **Coad** introduced the speaker of the night, Rod **McInnes**, an environmental economist who is a member of the Hornsby Shire Council's Catchment Remediation Program Committee and the Australian Agriculture Resource Economics Society. Rod used to work for the Sydney Catchment Authority part of Water NSW.

Chris **Taylor** apologised for not attending the November 2015 meeting and for not delivering the presentation that was organised for the committee's meeting.

3. DECLARATION OF PECUNIARY INTERESTS

No pecuniary interests were declared.

4. **PRESENTATION:**

Rod McInnes, currently an Agricultural and Resources Economist, gave a presentation on 'The Economics of Environmental Flows in the Hawkesbury'. Rod used to work for the Sydney Catchment Authority (SCA). Through his work on SCA, Rod was involved in a number of projects that advised on reducing nitrogen loads through the Brooklyn STP upgrade and worked on an environmental flows project as the economist. Rod's presentation described the process and variables (i.e. transparency and translucency) needed to consider in evaluating the management of dams such as Warragamba Dam from an economic point of view. Specifically, Rod described the challenges that Warragamba Dam has to allow for environmental flows since this asset was built not for this purpose. The presentation also mentioned a number of projects and modelling tools that have been developed for parts of the Hawkesbury estuary to quantify flushing times, algal activity and nutrient deliveries from certain STPs.

5. CORRESPONDENCE and MATTERS ARISING FROM PREVIOUS MEETING

7. <u>PROGRESS REPORT ON THE LOWER HAWKESBURY ESTUARY MANAGEMENT</u> <u>PROGRAM</u>

Ana Rubio – Hornsby Shire Council

Slight change to the delivery of the progress report by Hornsby Shire Council was trialled at the meeting based on feedback received by the members through a survey undertaken in August 2015. A summary of actions and projects related to the implementation of the Lower Hawkesbury Estuary Management Plan undertaken from the last meeting was sent to members with the agenda for this meeting. HSC presentation focussed on a number of key points identified in the summary document: a) work undertaken at One Tree Reach Wetland, b) coming up community events and c) a summary of future projects that we will work on prior to the end of the financial year.

Foreshore Clean-up

- End of 2015 Clean4Shore program.
- Waiting for final stats that will be included in a report produced by Tangaroa Blue, the data repository organisation. 2016 Clean4Shore program will be co-funded by Greater Sydney Local land Services, Gosford City Council and Hornsby Shire Council. Overall 12 trips in Hornsby LGA and 15 trips in Gosford LGA.
- 4x school presentations in the Hornsby area

Bush rehabilitation work

- Bush regeneration around Brooklyn Park, McKell Park and Kangaroo Point continues (OEH funded project)
- Dangar Beach coastal reserve planting took place last November. Ongoing monitoring. Assistance with watering from community members
- Floating Landcare event at Bar Island scheduled on 4th February had to be cancelled due to weather conditions. Contractors are currently working on Bar Island. Asset Protection Zone work around the graves
- Community education and bush regeneration event currently being organised by NPWS and partners at Milsons Passage, Date to be confirmed
- LLS funded project focusing on Juncus acutus currently being organised
- Preparation for burn control around Cunio Point, Berowra Ck

Mangrove Monitoring

- Mangrove health monitoring program continues.
- Specifically monitoring die-off downstream of Marlows Creek. RMS reported some mangrove clearing at Greenmans Valley Caravan Park, upstream Marlows Creek Gosford Council notified.

Seagrass markers

• One seagrass buoy around the Dangar Island seagrass bed has been lost (western side)currently being replaced by RMS.

One Tree Reach Wetland - hydrological and fish stock study update (Recreational Fishing Trust funds)

- Goal:
 - Understand the hydrologic processes of the wetland to ensure optimal management of the site to improve local fish stocks
- Outputs:
 - High resolution aerial photography = Digital elevation model vegetation assessment
 - Quantification of hydrological processes

- Fish stock assessment
- Water quality monitoring
- 2x Education workshops
- Field investigations:
 - First round of field days took place in February & March
 - Water quality monitoring (pH, EC, DO etc) of the open water area of the lagoon during the bathymetric survey was collected
 - A Conductivity-Temperature-Depth (CTD) probe downstream of the weir and surveyed to AHD was deployed and left for 5 weeks
 - A water level logger at the observation platform in the wetland and surveyed to AHD was deployed and left for 5 weeks
 - The bathymetry of the main open water section of the wetland was surveyed
 - Soil profiles were collected to assess the extent of Acid Sulfate Soils
- Future work:
 - Complete a bathymetric survey of the southern open water area of the wetland;
 - Complete a drone survey;
 - Download water level/quality loggers;
 - Collect additional soil profile data;
 - Produce a complete DEM of the wetland;
 - Determine a storage volume relationship of the wetland;
 - Provide recommendations on management.

Water quality monitoring buoys

- On-going water quality monitoring via autonomous real-time monitoring stations at 6 locations along the salinity gradient between Wisemans Ferry and the estuary entrance.
- Laughtondale probe was dragged a 1km downstream with the flood water during the January's heavy rainfall. No major damaged occurred. Thanks to Mary Howard for keeping an eye on this probe
- Slightly higher than usual incidences of algal blooms were observed this year in Berowra Creek prior to Christmas with no causative agent identified.

Swimming condition

• Swimming condition thresholds being review at present as we have more locations and more data. Last review of the thresholds was undertaken in 2010

Estuary health index

• Overall estuarine health levels, as per OEH scores, ranged between 'Good' and 'Fair' throughout the year with improved scores during winter when overall turbidity levels are low and with worse scores during summer when chlorophyll-a levels tend to be higher

Pacific Oyster Mortality Syndrome

- New outbreak in Tasmania in January 2016
- HSC and University of Sydney researchers have been advising the Tasmania industry based on findings from research undertaken in the Hawkesbury and Georges Rivers

Future projects:

- Seagrass awareness phone application in partnership with Macquarie University students (PACE program) – this project got cancelled in the last minute. Peter Coad asked Steve Brown if RMS might be looking at similar strategies to increase awareness of the location of seagrasses, but this is not the case.
- Review of toxic marine algal species to better informed management of algal blooms (UTS & HSC joint project). This project will assist with the management of algal blooms in the estuary

NSW Coastal Reforms

- Tim emphasized that Council is following closely the proposed changes to NSW Coastal reforms, in particular the initiative of replacing existing State Environment Planning Policies (SEPP 14 Coastal Wetlands, SEPP 26 Littoral Rainforests and SEPP 71 Coastal Management) with a new Coastal SEPP
- Redefining the 'coastal zone' with new mapping and coastal 'land use' categories, however mapping looks confusing

Rebecca Mooy – Greater Sydney Local Land Services

- \$350K of funding available across a number of Sydney Councils on bush regeneration
- Community funding National Landcare 2016 Clean4Shore project for 15 months (15 trips in Gosford and 12 in Hawkesbury)
- Pittwater YHI weed removal including kayaking trip
- Emergency chemical oil spill in waterways training
- Demonstration Farm in Richmond: composting, manure re-use, etc
- Bobbin Head Fishing Event
- 60 floating Landcare activities planned
- Promotional You-tube video shown on Floating Landcare

8. GENERAL BUSINESS

Council Amalgamations

Peter **Coad** informed members of the intention to continue with the LHEMP Committee however there is uncertainty in the process towards amalgamations. Currently Hornsby Shire Council is waiting for government responses on potential amalgamations with Kuring-Gai Council. Ana **Rubio** will keep members informed about any updates.

Hawkesbury Shelf Marine Bioregion Assessment

A number of members and representatives from both councils attended the March workshops for the Hawkesbury Shelf Marine Bioregion Assessment. Members were encouraged to review document and consider sending individual submissions.

Coastal Reforms

This topic was discussed during the Gosford City Council's report. Members are encouraged to update themselves with the proposed long-term strategy for the coordinated management of the coastal zone. Sydney Water Community Workshops update

Chris **Taylor** gave an update on the numerous meetings and workshops that he has attended lately with Sydney Water in regards to their facilities and sewage facility upgrades around Sydney. Chris had the opportunity of visiting facilities at Brookvale, Cooks River and Georges River. In each area they have different systems to deal with sewer under dry conditions, overflows and stormwater/wastewater. Sydney Water is concerned about the increased wastewater going through the reticulation pipes as a result of the significant increase in number of units in Sydney. Sydney Water is also assessing the possibility of reusing water to meet increase demand of drinking water.

Brooklyn Master Plan

Currently under consultation

Tenders were received in December 2015 and Council considered a report on the outcomes of the Tender evaluation at its meeting on 13 April 2016. Council resolved not accept any tender and negotiate with Elton Consulting and McGregor Coxall to arrive at a lump sum tender price. Next meeting is scheduled on 11th May. Other Business

• Richmond Air Force

Mary **Howard** was wondering if anyone had information about the firefighting foam chemicals used by the Richmond Air Force located close to the shores of the Hawkesbury. This was raised as a result of the contamination event of the Hunter River from similar contaminants used by the Williamtown Air Force base. Mick Pattison from Hawkesbury City Council provided an update on this:

1. Have the Richmond RAAF use the firefighting foam at the base in the past? Defence began using Aqueous Film Forming Foam (AFFF) containing Perfluorooctane Sulfanate (PFOS) and Perfluorooctanoic Acid (PFOA) for firefighting in the 1970s, and phased out its use in firefighting training between 2004 and 2011.

2. If so has the foam been used recently during a fire or practice operation? AFFF containing PFOS and PFOA has not been used recently at RAAF Base Richmond.

3. If the foam is used, are there any plans to stop using the chemical based on the findings of the inquiry from the Hunter River incident? AFFF containing PFOS and PFOA is no longer used for firefighting practice.

• Signs on the Fishing Industry history

Mary **Howard** enquiry about the opportunity of putting signs at Brooklyn, Wisemans Ferry and Patonga about the history of the local Fishing Industry. Some information on this topic will be developed through the UTS socio-economic study of the NSW wild fishing industry. Hornsby Shire Council is waiting for the appropriate theme-based funding to cover cost. In addition Gosford City Council mentioned that there might be opportunities through the team working on the Heritage Study.
