1. WELCOME

Meeting opened at 18:16. Meeting was chaired by Cllr **Tilbury**. Julie **Ryland** welcomed Jill **McDiarmid** who joined the meeting as an observer. Jill is a committee member of the newly formed Lower Hawkesbury River Residents Association of which Tim Irwin is the President and Michelle Armstrong is the Vice President. This Association was formed, initially, to represent the residents of Little Wobby Beach, Cogra Bay & other residents of the Lower Hawkesbury who do not have a collective representation, in relation to projects and plans for the Lower Hawkesbury. The Association is interested in ongoing and any one off issues that may arise from time to time, that may affect our communities or that we can contribute to.

4. **PRESENTATION:**

A presentation was given by Tim **Macdonald** from the Office of Environment & Heritage on the 'Changes to the NSW Coastal Management Framework'. This presentation was followed by an update on 'What we have achieved so far and what comes next in relation to the Lower Hawkesbury Estuary Management Plan' presented by Ana **Rubio**. Key points of each presentation have been listed below:

'Changes to the NSW Coastal Management Framework':

- Recent changes to legislation: Coastal Protection Act 1979 will be replaced by the Coastal Management Act 2016 was passed through Parliament (https://www.parliament.nsw.gov.au/bills/Pages/bill-details.aspx?pk=3291)
- Coastal Management Framework revised and sent for public exhibition (consolidate 3 SEPPs & divides the coastal zone into four management areas (coastal wetlands & littoral rainforest area; coastal vulnerability area; coastal environment area and coastal use area)-each of them have their own development controls- check OEH website for details
- Draft Coastal Management Plan (CMP):
 - New manual developed (still in draft)
 - Geographical scale: whole or any part of the coastal zone
 - Must identify: coastal management issues; actions required to address issues; how and when those actions are to be implemented, and funding of actions
 - Council must consult with the community and public authorities
 - \circ $\,$ Draft CMP adopted by council then submitted to the Minister for certification
 - A CMP must be reviewed at least once every 10 years
 - A copy of a CMP must be available for inspection by the public
 - Implemented through IP&R framework and land-use planning system
 - Public authorities are to have regard to a CMP
 - Development of CMP:
 - Stage 1- Scoping Study involves:
 - Determining the strategic context, purpose and scope of CMP
 - Determining where action is required (Council to develop maps of vulnerability areas where focus should go)

- A performance review of existing management
- Preparing a Scoping Report (i.e. knowledge gaps; risk analysis)
- Undertake any detailed studies of vulnerabilities and opportunities
- Response identification and evaluation
- Preparing, exhibiting, finalising, certifying and adopting a CMP
- Implementation, monitoring, evaluating and reporting
- Stage 2- Detailed studies of vulnerabilities and opportunities
- Stage 3- Response identification and evolution
- Stage 4- Finalise, exhibit, certify and adopt the CMP
- Stage 5- Implementation, monitoring and reporting
- Where to from here: Consolidate and build on efforts to date
- OEH funds will be available for 50% of cost for scoping studies can apply at any point
- 2021's goal is to have a new CMP

Mary **Howard** raised that water quality monitoring programs are hard to fund. She questioned if OEH will be funding monitoring program in the future. OEH will potentially fund monitoring programs that are highlighted as part of the Scoping Study during the development of CMPs.

ACTION 201703: There was uncertainty about the organisations and programs that are currently monitoring the waters of the Hawkesbury River. Ana **Rubio** will collate information on monitoring programs currently testing water quality in the Hawkesbury River (this includes the area managed by the Hawkesbury City Council)

'LHEMP - What we've done so far and what comes next'

- The Lower Hawkesbury Estuary Management Plan (LHEMP) was finalised and adopted by both Hornsby and Gosford (at the time) Councils in 2008
- During the development of the plan there was extensive community and stakeholder consultation in particular under three workshops: management situation; risk analysis and strategy formulation
- 148 strategies were developed for the plan- the breakdown was:
 - 27% Planning-related: ensuring planning instruments include best practice and provisions for sustainable development
 - 25% Research-related: undertaking program to monitor estuarine health and prepare for climate change
 - 20% Capital works/on-ground works: installing infrastructure and undertaking regeneration programs to protect estuarine assets
 - 15% Education-related: engaging riverside settlements to implement sustainable practices
 - 11% Compliance-related: encouraging riverside settlement sustainable practices
- Council keeps records in an informal way of the actions undertaken each year for the implementation of the estuary plan. This analysis will need to be undertaken using a more robust approach as part of the Scoping Study to be developed as part of the CMP. Based on our notes most of the strategies have been implemented:
 - $\circ~$ There are approximate 9% of the strategies that might not have been achieved fully.
 - We have implemented the highest number of strategies related to the 'Research' category; followed by 'Education'; 'Planning'; 'Capital Works' and the least of actions implemented were for the 'Compliance'-related strategies
 - Since 2004 Council has received close to \$2.8M in external grants (this excludes Council's cash contribution which in most cases is a 50:50). During this period

Council has applied for 90 funding applications to implement the LHEMP; 50 applications of which were accepted for funding.

• Council has also been recording additional information (occurrences of pollution events, algal blooms, assessments, etc..) related to some of the strategies that can be used for quantitative assessments of the implementation of the LHEMP

Mary **Howard** brought up observations on changes in the water quality of the upper reaches of the Hawkesbury River - it appears that turbidity levels are different and water is fresher (i.e. less salt) than usual.

ACTION 201704: Ana **Rubio** will present water quality data collected at the monitoring stations in the estuary during this financial year. The information will be presented as anomalies as it is the best way of seeing if recent years have been different from the historical averaged data.

ACTION 201705: The committee suggested that Sydney Water could be approached for a presentation on their latest water quality testing and modelling of environmental flows for the Hawkesbury. Ana **Rubio** will approach Sydney Water to engage them to present at an upcoming meeting.

- Where to from here? Discussions with the committee took place in regards to best approach to move forward in developing a CMP from the LHEMP. In order to do this the group was encouraged to think about:
 - the geographical scale (i.e. Windsor to Broken Bay, current extent covered by the LHEMP, a combination of small scale plans that focus in areas like Dangar Beach, Sandbrook inlet, etc..)
 - stakeholders to involve it was highlighted that many of the organisations that are members have not attended many meetings
 - communication methods to use across different associations that represent estuary river settlements
 - structure of the future plan- a large plan or a combination of small plans
 - how to integrate certified CZMP by the Hawkesbury City Council –some of their action will be related to the Lower Hawkesbury

ACTION 201706: Ana **Rubio** to disseminate among committee members the Hawkesbury City Council's Coastal Zone Management Plan (CZMP) highlighting those strategies that are directly related to the Lower Hawkesbury.

Chris **Taylor** reminded the committee the amount of work that Ross McPherson from Hornsby Shire Council has done through the years on estuarine-related projects. Chris suggested that Ross should be involved in any future consultation on the new CMP

ACTION 201707: Ana **Rubio** to contact Ross McPherson to present at upcoming LHEMP Committee meetings about Ross' overview on the changes that have occurred in the Lower Hawkesbury – in particular in relation to water quality.

Council's Asset Branch was also contacted in order to find out latest information from the successful contractor. **Complete**: Information was forwarded to the committee. Works on-site will start early in the financial year depending availability from the contractor (HSC TRIM D07231271).

7. <u>PROGRESS REPORT ON THE LOWER HAWKESBURY ESTUARY MANAGEMENT</u> <u>PROGRAM</u>

Ana Rubio – Hornsby Shire Council

A summary of actions and projects related to the implementation of the Lower Hawkesbury Estuary Management Plan for the period April to May 2017 was sent to members prior to the meeting. HSC presentation only focussed on a couple of key projects:

Bush regeneration and rehabilitation

• Brooklyn Bushcare group meets every 4th Thursday of every month in the coastal fringe opposite to the school. The group is currently looking for more volunteers. Please disseminate. Media releases are currently drafted

2017 World Environment Day and Native Plant Giveaway

- Festival will take place in Brooklyn at Upper McKell Park.
- Same day as River Reasons Festival which will be located in Lower McKell Park.
- Free shuttle bus from SaltPan Reserve
- Activities:
 - The festival will be jam packed with free activities and information stalls.
 - Fantastic frog displays
 - Amazing marine critter touch tanks
 - Colourful kids activities
 - Guided bushwalks (register on the day)
 - Learn about water pollution using a catchment model
 - Learn about native plants, weeds, waste, safe boating, river clean-ups and more...

- Free microchipping for Hornsby Shire dogs: Have your dog microchipped for Free or check/update your details; Dogs must be leashed and owner photo ID (18+) required for microchipping. Free giveaways with Council's Animal Control Officers on hand to answer questions.
- "All Aboard" Estuary Boat Tour: Celebrate World Environment Day and join us on a 40-minute tour by ferry offering a unique insight into the Lower Hawkesbury Estuary (\$5.00 per person).

- Update on amalgamations:

 - •Wamberal, Terrigal, Avoca, Cockrone and Pearl Beach Lagoons
 - •Lower Hawkesbury northern foreshore and tributaries
 - Warren's team is under the Group Leader of Assets, Infrastructure and Business > Senior Manager Property and Asset Manager (Peter Stokes) > Unit Manager Waterways and Coastal Protection. This has two sections: Coastal Protection and Waterways.
