RELATED POLICIES:

POLICY PURPOSE / OBJECTIVES:

1. To ensure the maximum availability of parking spaces to users.

POLICY STATEMENT:

1. Time limits for Council car parks will be determined in consultation with surrounding businesses and the general public giving due consideration to the location of the car park, the demand for parking spaces and the nature of the surrounding businesses.
 2. The parking infringement fines incurred in Council's parking areas will be administered by the Infringement Processing Bureau under the SEINS system. Decisions as to the waiving of fines will be made by the Bureau.
 3. Council will advise the Infringement Processing Bureau that consideration should be given to waiving fines in the following circumstances:-
-

- a) The offence resulted from unforeseen misadventure beyond the control of the offender who tenders to Council specific supporting evidence by way of medical certificate, statutory declaration and/or other documentation to Council's satisfaction.

OR

- b) In cases where the offence alleged is that some part of the vehicle is wholly or partly across the line marking the boundary between the parking space in which most of the vehicle was located and the adjoining parking space, the offender claims that no wheel of the vehicle in question was wholly over such dividing line and this claim cannot be disproved by a photograph taken by Council's inspector at the time of the alleged offence.

- 4. Enforcement of parking restrictions will be undertaken in a cost effective manner giving due consideration to:-

- a) Complaints regarding unavailability of parking.
- b) Number of vacant spaces in each carpark.

- 5. Enforcement of car parking restrictions in private car parking areas will be in accordance with enforcement in Council car parks and subject to lease agreements.
