## REFERRAL OF TRAFFIC MATTER FOR COMMENT OR OBJECTION, IF ANY

## **SUMMARY**

This report details the traffic implications of proposed temporary 'Works Zone' at 18 Waitara Avenue, Waitara, to build a new fourteen storey residential seniors living unit development comprising 117 independent living units and demolition of existing structures.

## **SUBJECT**

Council has received a request from 'Richard Crookes Constructions Pty Ltd' for a temporary 'Works Zone' at 18 Waitara Avenue, Waitara. The building project is in accordance with approved development application (DA/1016/2018).

The proposed 41 metres long 'Works Zone' is required to accommodate deliveries and construction vehicles during construction which has commenced at the site and is required for a period of 94 weeks initially. Providing the temporary 'Works Zone' along the site's frontage will minimise disruption to traffic when construction vehicles require access to the site. The area proposed as a works zone is currently unrestricted (45 degrees angle parking all day).

### CONSULTATION

No consultation is required as the location of the proposed 'Works Zone' is along the frontage of the construction site.

#### **RECOMMENDATION THAT**

1. 41m long "Works Zone 7am-5:00pm, Mon-Sat" be approved for installation at 18 Waitara Avenue, Waitara for the duration of the construction activity (initially 94 weeks) in accordance with Council's 2019/2020 Fees and Charges.
