Subject: Proposed Parking Restrictions

REFERRAL OF TRAFFIC MATTER FOR COMMENT OR OBJECTION, IF ANY

SUMMARY

This report details the traffic implications of proposed parking restrictions in Bridge Road and Roper Lane, Hornsby.

SUBJECT

Council has received a request from Hornsby TAFE to formalise parking restrictions along the access road between Bridge Road and TAFE carpark. A review of parking restrictions at the intersection of Bridge Road and Roper Lane has also identified inconsistent signposting.

The parking restrictions at the intersection need to be formalised to provide adequate sight lines and manoeuvring for vehicles. Parking restrictions are also proposed on the slip road leading to Hornsby TAFE to maintain two-way traffic flow to the site.

The proposal includes the following parking restrictions:

- 1. 'No Stopping' restrictions to be installed along both sides of the access road between Bridge Road and Hornsby TAFE.
- 2. 'No Stopping' restrictions to be installed at the intersection of Bridge Road and Roper Lane.
- 3. 'No Stopping' restrictions to replace existing 'No Parking' restrictions in Roper Lane, approximately 30 metres from Bridge Road.

Plans of the proposed parking restrictions are attached.

CONSULTATION

In May 2020, Council invited comments on the proposal. Fourteen (14) letters were sent to residents, tenants and TAFE, including emails to regulatory authorities, transport providers and TAFE. The proposal was also placed on exhibition on Council's website. One submission has been received from Ausgrid in support of the proposal. No responses were received from residents.

RECOMMENDATION THAT

- 'No Stopping' restrictions to be installed along both sides of the access road between Bridge Road and Hornsby TAFE.
- 2. 'No Stopping' restrictions to be installed at the intersection of Bridge Road and Roper Lane.
- 'No Stopping' restrictions be installed to replace existing 'No Parking' restrictions in Roper Lane, approximately 30 metres from Bridge Road in accordance with plan No LTC 12/2020.
