REFERRAL OF TRAFFIC MATTER FOR COMMENT OR OBJECTION, IF ANY

#### **SUMMARY**

This report details the traffic and parking implications for the proposed upgrade of an existing Children's Crossing by the installation of a Marked Pedestrian Crossing in School Road, Galston, to improve pedestrian safety in School Road, around Galston Public School (P/S Galston 39-45 Arcadia Road, Galston).

# **SUBJECT**

Council is proposing to install a Marked Pedestrian Crossing to replace the current Children's Crossing near Galston Public School on School Road, Galston. The installation of the Marked Pedestrian Crossing will provide a safe crossing location for pedestrians, especially school children and pedestrians accessing the school.

Key features of the proposal are:

- Installation of painted 'Zebra' marked crossing lines and pedestrian crossing signs.
- Extension of the 'No Stopping' Zone on the approach to the Crossing in School Road to 20m.

A plan of the proposal is attached.

#### Pedestrian Crossing Warrants - New crossing guidelines

In the past, the installation of marked pedestrian crossings on local roads was controlled by a Transport for NSW (TfNSW) crossing warrant system. TfNSW has now recognised that the warrants were difficult to achieve on local roads. In September 2022, TfNSW released new Pedestrian Crossing Guidelines. As an alternative to the TfNSW warrants, councils may use the following pedestrian demand calculation:

- In each of two separate one-hour periods in a typical day, the pedestrian flow per hour (P) crossing the road is, or is expected to be, equal to or greater than 20.
- Children and elderly or mobility impaired pedestrians count as two pedestrians.

Site observations of the pedestrian movements in School Road confirmed that the location meets the TfNSW guidelines.

#### **CONSULTATION**

Public Consultation has been conducted in December 2023.

Council invited comments on the initial proposal from Galston Public School, churches, residents and tenants. Twelve (12) letters were sent.

Council invited comments on the initial proposal from transport providers and authorities. Nine (9) letters were sent.

The proposal was also placed On Exhibition on Council's website for 14 days.

During the Public Consultation period, six (6) submissions were received by Council.

#### **CONCLUSION**

The submissions from residents and service providers have been addressed in the attached *Public Consultation Summary*. Council receives regular complaints from crossing supervisors and pedestrians in relation to drivers failing to stop at Children's Crossings due to lack of understanding of the 'Children's Crossing' rules. The changes to the crossing warrant system allow Council to upgrade these crossings to full time marked zebra crossings which are widely recognised and adhered to by drivers.
