1. WELCOME

Meeting opened at 18:30. Meeting was chaired by Cllr **Tilbury** who welcomed and thanked everyone for coming. Special thanks were given to members of the Bushland Management Advisory Committee who joined the meeting as part of their quarterly meeting.

3. DECLARATION OF PECUNIARY INTERESTS

4. PRESENTATION:

Steve **Federow**, group manager of Hornsby Shire Council's Environment & Human Services gave the a presentation on 10/50 monitoring within the Hornsby Shire. Steve described the background to the monitoring of tree loss in urban areas of Hornsby and the methodology used in the assessment. The assessment for the first 12 months of 10/50 resulted in 55% increase of tree canopy area lost, mainly for large trees. When canopy lost is applied to the whole suburban area excluding bushland areas there is a 3% canopy loss per year.

Cllr **Tilbury** updated the committee on progress regarding Brooklyn Masterplan and Council's amalgamations. Cllr Tilbury noted the preferred tenderer McGregor Coxall was accepted to work on the Brooklyn Masterplan. Particular emphasis will be given to parking and traffic in the area. Cllr Tilbury updated the group with the latest information on Council's amalgamations. On the 12th May NSW Premier Mike Baird and the Minister for Local Government Paul Toole announced 12 new councils in NSW. As part of this announcement Hornsby Shire Council lost the southern section of Epping, now being part of City of Parramatta Council. The potential merge of Hornsby Shire Council with Ku-ring-gai Council is still pending. 7. PROGRESS REPORT ON THE LOWER HAWKESBURY ESTUARY MANAGEMENT PROGRAM

Ana Rubio - Hornsby Shire Council

A summary of actions and projects related to the implementation of the Lower Hawkesbury Estuary Management Plan for the period March-May 2016 was sent to members prior to the meeting. HSC presentation focussed on a number of key projects identified in the summary document: a) progress on One Tree Reach Wetland's hydrologic study, b) real-time water quality monitoring and swimming condition maps, c) Clean4Shore program; d) Brooklyn's litter survey; e) upcoming community events and f) funding applications submitted.

One Tree Reach Wetland - hydrological and fish stock study update (Recreational Fishing Trust funds)

- Goal:
 - Understand the hydrologic processes of the wetland to ensure optimal management of the site to improve local fish stocks
- Project outputs:
 - High resolution aerial photography, digital elevation model and vegetation assessment
 - Quantification of hydrological processes
 - Fish stock assessment
 - Water quality monitoring
 - 2x Education workshops
- Progress:
 - Field investigations completed
 - Digital Elevation Model for the entire wetland has been completed

- Vegetation community assessment validated based on aerial photography taken by drones:
- Soil chemical characteristics from profile data currently being analysed
- Second fish survey undertaken
- Future work will focus on determining a storage volume relationship of the wetland and providing hydrological recommendations of the management the wetland

Water quality monitoring buoys

- Technical problems with the telemetry at Laughtondale monitoring station has resulted in delays in the delivery of data via the website. This has also affected the data feeds into the hydrodynamic model that runs daily to deliver swimming conditions. The modem and telemetry components have been upgraded to use 4G network, the system is now working.
- Continue higher than usual incidences of toxic algal blooms observed in Berowra Creek.

Swimming condition

- Quarterly (Jan-Mar) statistics on swimmable days reported: 85% at Brooklyn baths; 90% at Dangar Beach and 0% at Crosslands Reserve
- Swimming condition thresholds being review at present as we have more locations and more data. Last review of the thresholds was undertaken in 2010

Foreshore Clean-up

- Final report includes overall stats for the 2015 Clean4Shore program (available from Council's website)
- 8 tonnes of marine debris collected from the Hawkesbury through 12 trips. Top items reported: Foam insulation & packaging and plastic film remnants (bits of plastic bags, wrap, etc)
- Marine litter hotspots: Bar point area and Sandbrook Inlet
- Looking for high schools in Hornsby Shire to take part of the program flyer produced

Brooklyn litter survey

- Hornsby Shire Council's waste team seeking feedback in regards to litter hotspots / littering behaviour in the Brooklyn area
- There are currently 57 litter bins in Brooklyn but despite of this, litter still seems to be a problem
- A council staff has been talking to residents and businesses in the area
- Members were asked to send information and ideas on how to manage the litter issue in the area

- Working with turf growers and irrigation strategies
- Workshops on responsible fishing focus on non-English speaking community groups, in particular Chinese and Arabic groups
