## **SUMMARY**

This report details the traffic implications for the installation of parking restrictions in Quarry Lane, Dural. The parking restrictions are proposed to improve access for larger delivery vehicles to properties in Quarry Lane.

#### **SUBJECT**

Council has received a request from local residents to install parking restrictions along Quarry Lane. The residents have reported that when cars are parking on both sides of the road, there is no room for vehicles, especially trucks, to manoeuvre safely down the lane.

Quarry Lane is a sealed lane approximately 6m wide providing access to Pacific Hills Christian School driveways as well a number of semi-rural properties. Site inspections have confirmed that due to parking occurring around school finishing times the lane becomes inaccessible for larger vehicles.

It is proposed that:

'No Stopping, 2:30pm – 4pm, School Days' signs will be installed along the eastern side of Quarry Lane and between the existing 'No Stopping' zone near Quarry road and the end of the lane (approx. 200m)

## **CONSULTATION**

In November 2018, Council invited comments on the proposal from residents, occupiers, and Pacific Hills Christian School. The proposal was also placed on Council's website. Letters were sent to regulatory authorities and transport providers.

Two written responses were received from residents and the school. A summary of the comments and Council response is provided below. Copies of the response letters are available upon request:

Submission from resident and school - We do propose an amendment to the HSC proposed location of the 'No Stopping' Signs. We recommend that 'No Stopping' signs be erected on the eastern side of Quarry Lane, and deletion of the two proposed 'No Stopping' signs at the end of the lane on the school side.

Council response – Proposed part time 'No Stopping' signs will be erected along the eastern side of the Quarry Lane. Subject to monitoring in 2019 the signs will be converted to all day parking restrictions.

# RECOMMENDATION THAT

- 1. The 'No Stopping, 2:30pm 4pm, School days' signs will be installed on the east side of the Quarry Lane (200 metres long) as per plan LTC 43/2018.
- 2. That the operation of Quarry Lane be monitored in 2019 and the part time parking restrictions changed to permanent 'No Stopping' if warranted.
