REFERRAL OF TRAFFIC MATTER FOR COMMENT OR OBJECTION, IF ANY

SUMMARY

This report details the traffic implications, design and outcome of public consultation for the proposed installation of dedicated 'Car Share' parking spaces in Hornsby, Waitara and Pennant Hills.

SUBJECT

Car share is an innovative form of transport that allows people to hire vehicles on demand for short periods of time, via a telephone or internet booking service. The vehicles are parked in dedicated parking bays and are accessible to members at any time of the day or night. Members benefit from the flexibility of having access to a private vehicle without having to pay the fixed cost associated with owning a car.

Council at its meeting of 8 April 2020 has considered a report No GM6/20 in relation to Car Share Parking Policy and adopted the policy allowing car share companies to operate in Hornsby Shire. Following the adoption of the policy Council has been approached by 'Go Get' and has entered into a 12 month trial of car share scheme at 11 locations in Hornsby Shire.

The parking spaces will be implemented in accordance with the RMS / TfNSW Technical Direction (TTD 2018/001) Guidelines for on-street fixed space car share parking. Locations of the proposed car share spaces are detailed below:

CONSULTATION

In March 2021, 'GoGet' invited comments on the proposal from residents and occupiers within 50m radius of each location.

Summary of responses:

Forty-one (41) submissions were received Twenty-five (25) providing support for the proposal as advertised Five (5) supporting the scheme but suggesting alternate locations Eleven (11) objecting to the Car Share scheme in general

CONCLUSION

While majority of residents support the car share scheme and the introduction of parking spaces, some have raised concerns about the impact on parking availability in the immediate area or would prefer the space moved to another location.

A review of the locations has confirmed that there are no traffic and safety reasons to move the spaces. All locations have been reviewed by Council's Transport Planner and Senior Traffic Engineer. The proposal for car share parking at these locations is in accordance with Council's Car Share Parking Policy (2020). Parking surveys conducted by Council have also confirmed that dedicating **1 parking space at each location** will not have any adverse implications on parking available for residents.

Car share parking is suited to areas with high demand for parking, as car share schemes lead to a reduction in parking congestion. It has been shown in an inner city LGA in Sydney that 20% of car share members put off purchasing a second car (GoGet 2013).

RECOMMENDATION THAT

1. Installation of car share parking spaces designated as "No Parking - Authorised Car Share Vehicles Excepted" at 11 locations as detailed in the report be approved (for a 12-month to 18-month trial).
