**SUMMARY**

This report details the traffic implications of proposed temporary 'Works Zone' in Muriel Street, Hornsby to accommodate the construction of a single new dwelling at No 26 Muriel Street.

**SUBJECT**

Council has received a request from the owner of the property for a temporary 'Works Zone' at front of 26 Muriel Street, Hornsby. The site has been cleared and a single dwelling house has been approved for construction in accordance with (CDP/776/2022 - RESIDENTIAL - SINGLE NEW DWELLING - SEPP CONTROLS).

The proposed 9 metres long 'Works Zone' is required to accommodate deliveries and construction vehicles during construction which has commenced at the site and is required for a period of 19 weeks initially. Providing the temporary 'Works Zone' along the site's frontages will minimise disruption to traffic when construction vehicles require access to the site.

Plan showing Proposed Temporary Works Zone is attached.

**CONSULTATION**

No further consultation is required as the location of the proposed 'Works Zone' is along the frontage of the construction site.

**RECOMMENDATION THAT**

1. 9m long  
'Works Zone 7am-5:00pm, Mon-Sat'  
be approved for installation at 26 Muriel Street, Hornsby  
for the duration of the construction activity (initially 19 weeks)  
in accordance with Council's 2022 / 2023 Fees and Charges.
