## **SUMMARY**

This report details the traffic implications of the Proposed Council Public Event - **Spring Fest Hornsby 2024** to be held on Saturday 16 November 2024 along Peats Ferry Road, Hornsby, between Station Street and Coronation Street, Dural Lane, William Street and Dural Street.

## **SUBJECT**

**Spring Fest Hornsby 2024** will be held along Peats Ferry Road between Station Street and Coronation Street, Dural Lane, William Street and Dural Street, Hornsby. The event will feature the following:

- Main Stage program between 14:00 - 21:00 in the Dural Street carpark, continuous entertainment lineup.
- Expected attendance 9,000 - 10,000 people.
- There will be 15-18 food trucks / stalls and up to 5 markets stalls. set up on both car parks (Dural Street and William Street).
- Street art and performances, located mainly in or around the car park areas (Dural Lane)
- In addition to stage programming, there will be multiple roving street performers and multiple children's activities.
- Peats Ferry Road, will be closed between Dural Lane and Coronation Street - no heavy infrastructure will be placed there, and a 4-metre corridor will always be available for emergency services.
- Peats Ferry Road will have outdoor dining furniture stationed outside the restaurants to encourage patrons to visit the local businesses.
- Most of the roving entertainers and children's activities will occur on Peats Ferry Road.
- There will be a pop-up bar on the car park site and possibly an annex bar on Peats Ferry Road.  
(written confirmation has been sought from relevant police for non-enforcement of Alcohol-Free Zone, for the duration of the event)

Traffic implications of the event:

- Road closure of Peats Ferry Road between Coronation Street and Station Street.
- Road closures of Dural Lane and surrounding car parks.
- An emergency lane 4m wide minimum, will be always available.
- Vehicular access to emergency vehicles will be always maintained.
- Detours via Coronation Street and Station Street for local traffic and public transport vehicles.

A detailed Traffic Management Plan has been prepared in consultation with NSW Police, Transport for NSW and public transport operators. The main activities of the event will be contained within Dural Lane car parks and Peats Ferry Road will have outdoor dining furniture stationed outside the restaurants to encourage patrons to visit the local businesses.

It is anticipated that a proportion of the participants will arrive on foot and / or utilise public transport.

A copy of the Traffic Management Plan for Spring Fest Hornsby 2024 is attached to this report.

## **CONSULTATION**

Council's Community and Cultural Events Team has carried out extensive consultation with affected authorities, transport providers, retailers and residents during the preparation of the Traffic Management Plan (TMP).

Letters were provided to affected properties in September 2024.

Notification of the event, and its traffic impacts, is ongoing via Council's website.

There will be notification signage throughout the car parks at least two (2) weeks prior to the event.

Variable Message Boards (VMS) will be placed at key locations leading up to the event as detailed in the attached TMP.
