## **SUMMARY**

This report details the traffic implications of proposed "No Stopping" signs in Fraser Road, Normanhurst, near the intersection with Normanhurst Road, to improve safety at an existing traffic device **near Normanhurst Public School (4-6 Fraser Road / 2-12 Normanhurst Road / 98 Pennant Hills Road)**.

---

## **SUBJECT**

Fraser Road, near Normanhurst Road, has a raised platform which acts as a pedestrian facility. This traffic device was constructed by Council before the year 2000. School students and other pedestrians have been observed using this facility to cross Fraser Road which is facilitated by kerb ramps at the location.

Parents and carers from **Normanhurst Public School**, have raised road safety concerns about the intersection of Fraser Road with Normanhurst Road. Fraser Road currently does not have "No Stopping" signs near the intersection, and due to the raised platform, cars are sometimes parked within 10 metres of Normanhurst Road, or directly on the raised platform. This creates a road safety issue for all road users at this location.

To improve road safety by increasing sight distance for drivers at this location, Council proposes to install "No Stopping" signs in Fraser Road near Normanhurst Road. The length of the "No Stopping" zone will comply with Transport for NSW technical direction **TD 2011/01a** as 'Pedestrian Refuge Island Two Lane, Two Way with Kerb Extension' (the existing holding rails at the sides of the raised platform can act as kerb extensions).

The new parking regulations will result in the loss of three (3) informal parking spaces, and the loss of one (1) formal parking space, at the location, noting that when the device was built before the year 2000, it was not envisaged that drivers would attempt to park on it.

The proposal:

1. Installation of a "No Stopping" sign (left arrow) on the north side of Fraser Road, 20 metres from Normanhurst Road.
2. Installation of a "No Stopping" sign (right arrow) on the south side of Fraser Road, 40 metres from Normanhurst Road (25 metres from the kerb ramp).

## **CONSULTATION**

The installation of the parking restrictions at this location is considered essential, to maintain safety of school children and other pedestrians who use the traffic device. Public Consultation in this case, to gauge public opinion of the proposal, is considered unnecessary due to risk factors with the current traffic conditions.

Residents who are directly affected by the new signs will be notified of the changes before installation.

## **CONCLUSION**

The removal of parking near the device is mandated by the Australian Standards and Traffic Engineering guidelines. The proposed parking regulations will improve safety of pedestrians at this existing pedestrian facility in Fraser Road.
