SUMMARY

This report details the traffic implications of proposed temporary 'Works Zone' in Copeland Road, Beecroft, to accommodate construction of an approved single dwelling. (DA/764/2016)

SUBJECT

Council has received a request from 'Samuel Homes' for a temporary 'Works Zone' at 121a Copeland Road in Beecroft. The construction activity is associated with approved construction of a single dwelling.

The proposed 18 metre long 'Works Zone' is required to accommodate deliveries and construction vehicles during construction which has commenced at the site and is required for a period of 12 weeks. Parking along the frontage of the site is currently unrestricted. Parking demand in the area is generally high due to commuter parking and school. Providing the temporary 'Works Zone' along the site's frontage will minimise disruptions to traffic when delivery vehicles arrive at the construction site.

If no issues arise, consideration will be given to extending the duration of the 'Works Zone' at the builder's request.

CONSULTATION

Due to the location of driveways and road geometry it is not possible to provide the full length of the work zone in front of the work site. The proposed work zone will partially be located in front of no 123 Copeland Road. The affected property owners will be notified of the temporary work zone (12 Weeks).

RECOMMENDATION THAT

1. 18m long "Works Zone 7am-5pm, Mon-Sat" be approved for installation at 121a / 123 Copeland Road, Beecroft, for the duration of the construction activity (12 weeks) in accordance with Council's Fees and Charges.
