## REFERRAL OF TRAFFIC MATTER FOR COMMENT OR OBJECTION, IF ANY

## **SUMMARY**

This report details the traffic implications of proposed temporary 'Works Zone' at 45 Ida Street, Hornsby, to accommodate the construction of a double storey dwelling.

## SUBJECT

Council has received a request from Lai Yee Chan - **WKZONE/14/2022** for a temporary 'Works Zone' at front boundary of **45 Ida Street, HORNSBY**.

The building works project is in accordance with:

Approved CDP/439/2022 - Construction of a Two Storey Dwelling - SEPP Controls Complying Development Certificate - Private <u>Principal Certifying Authority:</u> New Home Certification Group PO Box 826 CONCORD NSW 2137 <u>Accredited Certifier:</u> Rebecca Baillie Care New Home Certification Group PO BOX 826 CONCORD NSW 2137

The proposed **15 metres long** 'Works Zone' is required to accommodate deliveries and construction vehicles during construction which has commenced at the site and is required for a **period of 13 weeks** initially.

Providing the temporary 'Works Zone' along the site's frontages will minimise disruption to traffic when construction vehicles require access to the site.

Due to the presence of significant traffic during the afternoon school pick-up times, (Hornsby North Public School) the proposed 'Works Zone' times have been limited to 2pm on school days.

Plan showing Proposed Temporary Works Zone is attached.

#### **CONSULTATION**

No further consultation is required as the location of the proposed 'Works Zone' is along the frontage of the construction site.

#### **RECOMMENDATION THAT**

1. 15 metres long

'WORKS ZONE 7AM-2:00PM (SCHOOL DAYS) - 7AM-5PM (ALL OTHER MON-SAT)' be approved for installation at 45 Ida Street, HORNSBY for the duration of the construction activity (initially 13 weeks) in accordance with Council's 2022/2023 Fees and Charges.
