Subject: Proposed Signage and Delineation to formalise existing road rules

REFERRAL OF TRAFFIC MATTER FOR COMMENT OR OBJECTION, IF ANY

SUMMARY

This report details the traffic implications of proposed signage and delineation installation in Bolton Avenue near the intersection with Ku-Ring-Gai Chase Road, Mount Colah. The installation is proposed to occur concurrently with road construction works, to minimise disruption to residents.

SUBJECT

Council has reviewed the existing traffic and parking conditions in Bolton Avenue in conjunction with upcoming civil works. Bolton Avenue is a local road. Kuring-Gai Chase Road is a State Road under the jurisdiction of Transport for NSW. The two roads meet at a T-intersection, which is currently not signposted, and operates under the Australian Roads Rules.

The civil works project involves kerb and gutter construction, as well as some minor drainage works and pavement reconstruction. The works are anticipated to take approximately 12 to 14 weeks dependent on the weather.

The proposed concurrent traffic and parking improvements consist of:

- 1. Formalising the T-intersection with "Give Way" sign and "Give Way" delineation.
- 2. Installation of double barrier lines in Bolton Avenue on the approach to Kuring-Gai Chase Road.
- 3. Installation of "No Stopping" restrictions in Bolton Avenue near the intersection.
- 4. Installation of "Bus Zone" signs at the existing bus stops.

CONSULTATION

Public Consultation was performed by Council's Design and Construction Branch in June 2023. Residents of Bolton Avenue were notified by letter about upcoming civil works "Proposed Road Reconstruction - Bolton Ave, Mount Colah". The proposed works, listed in Council's Local Roads Improvement Program, were also exhibited on Council's Your Say website.

Further consultation is not warranted as the proposed signage and delineation will formalise the existing road rules that apply to an intersection.

RECOMMENDATION THAT

- 1. 'No Stopping' restrictions in Bolton Avenue near the intersection with Kuring-Gai Chase Road be approved.
- 2. 'Bus Zone' signs in Bolton Avenue near the intersection with Kuring-Gai Chase Road be approved.
- 3. Installation of 'Give Way' sign and associated delineation in Bolton Avenue be approved.
