REFERRAL OF TRAFFIC MATTER FOR COMMENT OR OBJECTION, IF ANY

#### **SUMMARY**

This report details the traffic implications of proposed temporary 'Works Zone' and a 'No Parking' zone in Bell Street, Hornsby, to accommodate the construction of 71 residential flat buildings at 9 Bell Street and to provide a permanent turn around facility in the cul-de-sa

### **SUBJECT**

Council has received a request from Draycon Building Pty Ltd for a temporary 'Works Zone' at the side boundary of Bell Street, Hornsby. The building works project is in accordance with (DA/214/2015).

# Proposed Temporary Works Zone

The proposed 15 metres long 'Works Zone' is required to accommodate deliveries and construction vehicles during construction which has commenced at the site and is required for a period of 8 weeks initially. Providing the temporary 'Works Zone' along the site's frontages will minimise disruption to traffic when construction vehicles require access to the site.

## Proposed permanent 'No Parking' restrictions

Residents and Council's waste management services have reported that the rezoning of Bell Street and recent construction of residential units have created difficulties for service vehicles turning at the end of the road. The parking occurring in the cul-de-sac is also making access to existing driveways difficult.

It is proposed that permanent 'No Parking' restriction be installed in the cul-de-sac of Bell Street to improve turn around facility for service vehicles.

#### **CONSULTATION**

In May 2020, Council invited comments on the proposal from residents and occupiers. The proposal was also placed on exhibition on Council's website. Seven (7) letters were sent to residents and occupiers, as well as regulatory authorities and transport providers. Two submissions have been received by Council. Copy of the submissions is available upon request.

Submission from resident – Support the installation of the permanent 'No Parking' zone in the bulb of the cul-de-sac. Strongly object to the installation of the temporary 'Work Zone' in the street. The construction traffic has had significant impact to residents to date. Illegal construction activity has impacted on access to properties.

Response – The numerous non-compliance issues noted by the resident have been referred to Council's Compliance Branch for investigation. Experience from other locations shows that the installation of the formal temporary 'Work Zone' will assist with managing construction traffic in the street and result in less disruption to residents.

Submission from resident – We vote for the proposal. Looking forward to it being implemented soon.

Response – Comments noted.

## **RECOMMENDATION THAT**

1. 15m long temporary 'Works Zone 7am-5:00pm, Mon-Sat' be approved for installation at 9 Bell Street, Hornsby, for the duration of the construction activity (initially 8 weeks) in accordance with Council's 2019/2020 Fees and Charges.

2. Permanent 'No Parking' restrictions be installed in the turning head of the cul-de-sacs of Bell Street, Hornsby as per plan No LTC 14/2020.
