REFERRAL OF TRAFFIC MATTER FOR COMMENT OR OBJECTION, IF ANY

SUMMARY

This report details the traffic implications of proposed disabled parking space and temporary 'Works Zone' at 4 Chilvers Road, Thornleigh to accommodate the building works and future occupation of the office space by Hornsby Shire Council staff.

SUBJECT

Council has received a request from Council's contractor (Sudiro Constructions Pty Ltd) for a temporary 'Works Zone' at the side boundary of 4 Chilvers Road. The future use of the office space also requires the provision of permanent disabled parking space that cannot be accommodated on site due to site constraints.

Proposed temporary 'Works Zone'

The proposed 12 metres long 'Works Zone' is required to accommodate deliveries and construction vehicles during construction which has commenced at the site and is required for a period of 8 weeks initially. Providing the temporary 'Works Zone' along the site's frontages will minimise disruption to traffic when construction vehicles require access to the site. The area in front of the site is currently unrestricted but subject to high demand for parking due to nearby industrial and commercial zoning.

Proposed permanent 'Disabled Parking' space with indent bay and ramp

The proposed disabled parking space will be 7.8m long. An access ramp and indent bay (900mm kerb offset) will be constructed in Chilvers Road to ensure compliance with design standards for on-road disabled parking spaces. A ramp will also be constructed within the site linking the parking space with the entry to the office space at the premises.

CONSULTATION

No further consultation is required as the location of the proposed disabled parking space and 'Works Zone' are along the frontage of the construction site.

RECOMMENDATION THAT

- Proposed temporary 12m long "Works Zone 7am-5:00pm, Mon-Sat" be approved for installation at 4 Chilvers Road, Thornleigh be approved for the duration of the construction activity (initially 8 weeks).
- 2. Proposed permanent 'Disabled Parking' space with indent bay and ramp at 4 Chilvers Road, Thornleigh be approved as per the attached plan.
