### **SUMMARY**

This report details the traffic and parking implications of proposed delineation and formalising of ‘Give Way’ controls at the intersections of:

- Evans Road and Galston Road,
- Evans Road and Grevillea Crescent,
- Grevillea Crescent and Galston Road.

---

**SUBJECT**

Council has received a complaint from a local resident in relation to traffic operation and parking occurring at the subject locations. It has been reported that vehicles are parking too close to the intersection of Evans Road and Galston Road, not keeping left in lane of the road at the intersections of Grevillea Crescent and Evans Road, and Grevillea Crescent and Galston Road.

Investigation and monitoring of sites by Council staff found that:

- Vehicles parked near intersections were parked legally and in accordance with the Road Rules (10m or more away from intersection). No further action is recommended. Monitoring will continue.
- Due to lack of delineation at intersections vehicles often took an incorrect path while turning at the intersections. Installation of delineation and Give Way signs are recommended.
- Crossing of Grevillea Crescent near the intersection with Galston Road would be improved by the provision of a pedestrian refuge.

**The Proposal:**

1. Installation of 'Give Way' sign and delineation in Evans Road at the intersection with Galston Road.
2. Installation of 'BB' lines at existing 'Give Way' facility in Grevillea Crescent at the intersection with Evans Road.
3. Installation of 'Give Way' sign and delineation in Grevillea Crescent at the intersection with Galston Road.

A concept plan is attached.

**CONSULTATION**

The proposal has been developed following monitoring of the location. Further consultation is not required as the proposed 'Give Way' installation does not impact on parking, changes to the priority or operation of the intersections.

**CONCLUSION**

Formalising of the intersections with 'Give Way' signs and delineation road markings will improve driver awareness of intersection geometry and improve traffic flow and safety at these locations.

**RECOMMENDATION THAT**

1. Installation of 'Give Way' sign and delineation in Evans Road at the intersection with Galston Road be approved.
2. Installation of 'BB' lines at existing 'Give Way' facility in Grevillea Crescent at the intersection with Evans Road be approved.
3. Installation of 'Give Way' sign and delineation in Grevillea Crescent at the intersection with Galston Road be approved.
4. Design be prepared for a pedestrian refuge islands in Grevillea Crescent near Galston road and consideration be given to submitting the project under future funding programs.
