Subject: Proposed Temporary 'No Parking – Authorised Vehicles Excepted' Zone

REFERRAL OF TRAFFIC MATTER FOR COMMENT OR OBJECTION, IF ANY

SUMMARY

This report details the traffic and parking implications for the installation of temporary 'No Parking – Authorised Vehicles Excepted' zone at the front of Council's Administration Centre to accommodate Council's operational fleet during urgent building works.

SUBJECT

Council has identified the need to temporarily accommodate its operational vehicle fleet during urgent building works that have commenced in the Administration Centre at 296 Peats Ferry Road, Hornsby.

It is proposed that the existing nine parking spaces currently zoned as 2P be temporarily converted to 'No Parking – Authorised Vehicles Excepted' for the duration of the works, initially 8 weeks. The existing disabled parking space will remain unaffected.

Parking implications for the temporary change are considered minimal as the building works have resulted in significantly reduced parking demand at the Administration Centre.

CONSULTATION

Public consultation is not required due to the temporary nature of the change and its location directly in front of the administration centre.

It is also noted that 12 parking spaces located at the rear of the Council building will be temporarily converted to 'No Parking – Authorised Vehicles Excepted'. The existing disabled parking space will remain unchanged. As this area is within Council's operational land, the Local Traffic Committee is informed of this change.

CONCLUSION

These temporary parking changes are aimed at accommodating Council's operational vehicle fleet to ensure continuation of service provision for the residents.

RECOMMENDATION THAT

 Nine parking spaces currently zoned as 2P located at 296 Peats Ferry Road, Hornsby be temporarily converted to 'No Parking – Authorised Vehicles Excepted' for the duration of the works, initially 8 weeks.
