REFERRAL OF TRAFFIC MATTER FOR COMMENT OR OBJECTION, IF ANY

SUMMARY

This report details the traffic implications of proposed temporary 'Works Zone' at No 27 Unwin Road, Waitara to accommodate the construction of a two-storey single dwelling.

SUBJECT

Council has received a request from Clarendon Homes (NSW) Pty Ltd for a temporary 'Works Zone' at the side boundary of 27 Unwin Road, Waitara. The building works project is in accordance with approval (CDP/1311/2021 - Complying Development Certificate - Private).

The proposed 12 metres long 'Works Zone' is required to accommodate deliveries and construction vehicles during construction which has commenced at the site and is required for a period of 42 weeks initially. Providing the temporary 'Works Zone' along the site's frontages will minimise disruption to traffic when construction vehicles require access to the site.

CONSULTATION

No further consultation is required as the location of the proposed 'Works Zone' is along the frontage of the construction site.

RECOMMENDATION THAT

1. 12m long 'Works Zone 7am-5:00pm, Mon-Sat' be approved for installation at 27 Unwin Road, Waitara, for the duration of the construction activity (initially 42 weeks) in accordance with Council's 2021/2022 Fees and Charges...
