REFERRAL OF TRAFFIC MATTER FOR COMMENT OR OBJECTION, IF ANY

SUMMARY

This report details the traffic and parking implications of proposed 'Bus Zone' and 'No Stopping' signs at east of intersection of Lockwood Street with Olive Street. These two bus stops are currently operating and this proposal is to regulate them.

SUBJECT

Council has been approached by residents and bus operators in relation to illegal parking occurring at existing bus stops in Lockwood Street near the intersection with Olive Street.

To address the ongoing enforcement issues at the location it is proposed to regulate two bus stops at east of intersection of Lockwood Street with Olive Street by installation of 'Bus Zone' signs and 'No Stopping' signs near the intersection. The details of the 'Bus Zones' are shown on attached drawing LTC 03/2019. The installation of the signs will ensure that buses can pull in close to the kerb to set down and pick up passengers.

CONSULTATION

Regulating existing bus stops will not have any adverse impact to the community or the bus company. There will be no loss of on-street parking as the Australian Road Rules prohibit parking at bus stops and stopping within 10 metres of intersections. It is recommended that nearby residents be informed of the approval before installation.

RECOMMENDATION THAT

- 1. Two 'Bus Zones' approximately 22 metres long at the north side and 30 metres long at the south side be installed in Lockwood Street near the intersection with Olive Street as per drawing No LTC03/2019.
- 2. 10 metre 'No Stopping' restrictions be installed at the intersection of Lockwood Street with Olive Street as per drawing No LTC03/2019.
- 3. Residents in the immediate area be notified of LTC's recommendation.
