REFERRAL OF TRAFFIC MATTER FOR COMMENT OR OBJECTION, IF ANY

SUMMARY

This report details the traffic and parking implications of proposed bicycle racing events that will be held throughout 2021 in the Mount Kuring-Gai industrial area. The events are organised by the Northern Sydney Cycling Club and have been held in the area for over 11 years with minimal disruption to traffic.

SUBJECT

Northern Sydney Cycling Club is requesting approval to continue using Beaumont Road Mount Kuring-Gai, for regular Sunday morning bicycle racing events. Current Local Traffic Committee approval expires 20 December 2020 (LTC Reference 28/2019). Northern Sydney Cycling Club has requested Local Traffic Committee approval to extend to **19 December 2021**.

A list of proposed dates and Traffic Management Plan (TMP) are attached.

Beaumont Road is a local dead-end road serving an industrial subdivision with limited traffic and parking activity on Sunday mornings. The event organiser has presented a Traffic Management Plan (TMP) in accordance with Transport for NSW 'Guidelines for Bicycle Road Races'. This event falls under the definition of a Class 2 established route event. Essentially the road will remain open during events with signage and traffic control marshals posted at intersections and the start / finish line. Normal road rules will apply to racers and the public.

Following consultation with local businesses and Council, the organiser has modified the TMP to ensure events will be limited to start at 8:15 am and finish at 10:00 am to avoid conflict with buses accessing the Transdev bus depot.

The start / finish line for the event has been relocated towards the intersection of Beaumont Road and Hamley Road to avoid the ongoing traffic conflict present during the allocated days with Council's Waste Services depot. Hence the driveways for No. 5 and 7 Beaumont Road, Mount Kuring-Gai will maintain open for access at all times during the events. A traffic controller will be present at the subject location to allow cyclists to perform a U-turn safely.

The event has run for a number of years previously. To date Council has not received any complaints or concerns from the public regarding the events.

Council approval of the event will be subject to the following conditions:

1. All sign posting and event supervision to be in accordance with the submitted Traffic Management Plan and conforming to the requirements of the Transport for NSW publication 'NSW Guidelines for Bicycle Road Races'.
2. The organiser shall supply, erect and maintain for the duration of the event all traffic control measures, including barriers, sign posting and marshals in accordance with the Traffic Management Plan.
3. Competitors are to obey all traffic regulations during the event and be mindful of other vehicles using the road.
4. A Transport for NSW certified traffic controller shall be posted at each intersection and at the eastern end of Beaumont Road.
5. All traffic controllers shall be suitably qualified in accordance with Transport for NSW requirements.
6. A copy of a public liability insurance policy for a minimum of \$20 million with a certificate of currency naming Council, Transport for NSW and NSW Police as interested parties shall be forwarded in advance to Council's Risk and Insurance Manager by the organiser to cover racing for the period from **3 January 2021 until 19 December 2021**.
7. That NSW Police, Transport for NSW and Hornsby Council should be included in a statement of waiver or release of damages on participant registration forms.
8. The local Police shall be advised of the event and any Police requirements shall be complied with.
9. All noise and especially an amplification system shall be of a character which is not deemed to be offensive as defined by the Noise Control Act.
10. That the organiser shall be responsible to keep the area clean and tidy and will reimburse Council or rectify any damage occurring as a result of this event.
11. That the organiser shall notify Fire Brigades and Ambulance Service of the dates and times of the current race series for dates up to **19 December 2021**.
12. That the organiser shall carry out a letter box drop to all affected businesses and residents notifying them of dates and times of the current race series for dates up to **19 December 2021**.
13. That the organiser shall advise Council in advance of the dates of its next round of racing from **3 January 2021 to 19 December 2021**. This information shall also be forwarded to NSW Police, Fire Brigades, Ambulance Service, affected businesses and residents as per the current race series.
14. This approval is subject to the written consent of the Commissioner of Police under Section 40 of the Road Transport (Safety and Traffic Management Act) 1999.
15. This approval will be reviewed every twelve months or at any time if complaints are received.

The recommendation of this item is subject to Council's Risk & Audit Manager and Manager Asset Management and Maintenance being satisfied that their requirements are met.

CONSULTATION

That the organiser shall carry out a letter box drop to all affected businesses and residents notifying them of dates and times of the current race series for dates up to **19 December 2021**.

RECOMMENDATION THAT

1. Council approve the use of Beaumont Road for Bicycle Road Races on Sundays between 8:15am and 10:00am subject to the conditions listed above.
2. This approval is valid for the period **3 January 2021 to 19 December 2021**.
