REFERRAL OF TRAFFIC MATTER FOR COMMENT OR OBJECTION, IF ANY

SUMMARY

This report details the traffic implications of a Proposed Temporary Works Zone in Water Street, to accommodate the construction of a Gross Pollutant Trap (GPT) in Beatrice Thomson Park.

SUBJECT

Council is about to commence works in Beatrice Thomson Park in Water Street. The works will involve storage and installation of a Gross Pollutant Trap (GPT) into the ground. Parking occupancy in Water Street is moderate due to it being located in a medium density area. Majority of the park will remain open during the works, apart from the construction site, where the GPT will be installed.

Large vehicles (such as excavator, low loader truck, crane, concrete trucks) will not be able to park on this site. Providing the temporary 'Works Zone' along the site's frontage will minimise disruption to traffic when construction vehicles require access to the site. It will also isolate heavy construction vehicles from the general parking.

CONSULTATION

No further consultation is required as the location of the proposed 'Works Zone' is along the frontage of the construction site, the frontage of Council's park.

Park users will be informed by signs located in the park, of the upcoming works and impact on parking.

RECOMMENDATION THAT

1. 50-metre long 'Works Zone 7:00am to 5:00pm, Monday-Saturday' be approved for installation at 2-6 Water Street, (Beatrice Thomson Park) Hornsby for the duration of the construction activity, initially 10 weeks.
