SUMMARY

This report details the traffic implications of proposed temporary 'Works Zone' at No 10C Palmerston Road, Waitara, to build a new residential (single dwelling). (CDP 108/2019).

SUBJECT

Council has received a request from 'Clarendon Homes Pty Ltd' for a temporary 'Works Zone' at 10C Palmerston Road in Waitara. The building works project is in accordance with CDP 108/2019.

The proposed 15 metre long 'Works Zone' is required to accommodate deliveries and construction vehicles during construction which has commenced at the site and is required for a period of 8 weeks initially. Providing the temporary 'Works Zone' along the site's frontage will minimise disruption to traffic when construction vehicles require access to the site. The area proposed as a works zone is currently unrestricted.

CONSULTATION

As property number 10C Palmerston Road is a battle-axe block, the zone will be partially in front of other nearby properties. The applicant has contacted the adjacent neighbours who have expressed written support to the temporary works zone.

RECOMMENDATION THAT

1. 15m long "Works Zone 7am-5:00pm, Mon-Sat" be approved for installation at 10C Palmerston Road, Waitara for the duration of the construction activity (initially 8 weeks) in accordance with Council's 2018/2019 Fees and Charges.
