

Fagan Park Annual Car Parking Permit Conditions

- To be eligible to apply for an online annual Fagan Park car parking permit you must have a valid Hornsby 1. Shire residential address where your permit will be posted. It is your responsibility to ensure the postal address is correct at time of application. The permit is only to be used by the person whose name appears on the permit.
- 2. The annual car parking permit is valid for one privately-owned motor vehicle (up to 8 seats) or motorcycle. Annual permits are not valid for taxis, hire/rental motor vehicles, buses, or mini-buses and they must purchase a day Pay and Display ticket.
- Annual parking sticker can only be used for the motor vehicle registration, as per permit details and is not 3. transferable nor can it be altered.
- 4. Annual permit stickers will not be refunded or replaced if lost, misplaced, used or if left on vehicle if sold.
- 5. Annual permit allows access to Arcadia Road and Carrs Road carparks and when in use Arcadia Road overflow carpark.
- 6. Annual car parking permits are only available online. Please allow 10 working days from date of payment for processing. In the interim to gain access to Fagan Park carparks until you receive your permit and sticker, please print your application email confirmation and display on your vehicle dashboard or inside a registration label holder attached to your motorcycle.
- Whilst parked within Fagan Park carparks a valid annual permit sticker must be clearly placed on the 7. vehicle's internal front windscreen, on a non-tinted section. which doesn't obstruct the driver's vision or inside a registration label holder attached to a motorcycle. Alternatively, you must purchase a day Pay and Display ticket ensuring ticket is placed on vehicle's dashboard (printed side face up) or inside motorcycle registration label holder to display printed side of ticket.
- Please allow sufficient time to purchase your Pay and Display ticket, especially during special events, 8. weekends and school holidays.
- 9. Fines do apply for vehicles not displaying a current annual permit sticker or a valid day parking ticket.
- 10. Permits are valid for a period of 12 months from commencement date. The commencement date will be the first day of the month indicated by a hole punch on the sticker. Your confirmation letter will clearly indicate commencement and end dates.
- 11. Please ensure you park within designated parking bays (fines do apply).
- In order for our online permit system to function appropriately, it is necessary for you to provide us with 12. limited amounts of personal information. We take your privacy seriously. We will at all times collect, store, use and disclose your personal information in accordance with the Privacy Act 1988 (Cth), the Australian Privacy Principles and our Privacy Policy - hornsby.nsw.gov.au/online-privacy-statement.
- 13. Bookings for Picnic Shelters, Wedding Ceremonies and Wedding Photos at Fagan Park do require a separate online application (fees apply). Bookings are only accepted from persons 18 years of age and over.
- 14. Failure to observe the above conditions may result in cancellation of future permits.
