REFERRAL OF TRAFFIC MATTER FOR COMMENT OR OBJECTION, IF ANY

SUMMARY

This report details the traffic implications of proposed temporary 'Works Zone' in Alexandria Parade, Waitara, to accommodate the construction works for **Waitara Station Upgrade** by Transport for NSW.

SUBJECT

Council has received a request from

Gartner Rose Pty Ltd

4/312 High Street

CHATSWOOD NSW 2067

(on behalf of Transport for NSW) for a temporary 'Works Zone' in Alexandria Parade, Waitara along the existing 90 degree parking area opposite Orara Street. (WKZONE/4/2022)

The works are associated with NSW Government Transport for NSW 'Transport Access Program' providing lifts and other access improvements at railway stations.

"The Transport Access Program (TAP) is delivering a better experience for public transport customers across NSW by providing accessible, modern, secure and integrated transport infrastructure."

The proposed 30 metres long 'Works Zone' is required to accommodate preliminary construction works for the **Waitara Station Upgrade** including a new pedestrian tunnel in this vicinity. Providing the temporary 'Works Zone' along the site's frontages will minimise disruption to traffic and improve access to the site for contractors.

Parking along this section of Alexandria Parade is currently unrestricted and predominantly used as commuter parking. The 'Works Zone' will remove *12 parking spaces* for the duration of 13 weeks initially. While no offset parking is proposed by TfNSW at the present time, Council, in its submission for the proposed **Waitara Station Upgrade**, has requested that consideration be given to providing additional commuter parking at Waitara Railway Station in conjunction with the upgrade.

This request is currently being considered by TfNSW as part of the detailed design.

CONSULTATION

Transport for NSW has consulted with local residents and businesses about the project and its impacts. An approval for the works to proceed, subject to detailed design, has been issued by the Secretary for Transport for NSW in accordance with Division 5.1 of the EP&A Act.

It is noted that, while the impacts of the proposed 'Works Zone' are temporary, a further report will be presented to the Local Traffic Committee outlining the final design of the **Waitara Station Upgrade** and its implications on the local road network.

This information is yet to be finalised and provided to Council by TfNSW.

RECOMMENDATION THAT

1. 30m long "Works Zone 7am-5:00pm, Mon-Sat" be approved for installation at Alexandria Parade, Waitara for the duration of the construction activity (initially 13 weeks) in accordance with Council's 2021/2022 Fees and Charges.
 2. A further report be presented to the Local Traffic Committee outlining the final design of the **Waitara Station Upgrade** and its implications on the local road network.


