Subject: Proposed parking restrictions

REFERRAL OF TRAFFIC MATTER FOR COMMENT OR OBJECTION, IF ANY

SUMMARY

This report details the traffic implications of the proposed parking restrictions on Edgeworth David Avenue near Jubilee Street, Wahroonga.

SUBJECT

Council has received requests from residents who are concerned that vehicle drivers do not have sufficient sight distance when turning at the intersection of Edgeworth David Avenue with Jubilee Street.

A review of crash data for the intersection of Edgeworth David Avenue with Jubilee Street shows that there was one injury crash at this intersection in 2021. A vehicle travelling through Edgeworth David Avenue crashed with another vehicle coming out of Jubilee Street, Wahroonga.

Council's Traffic Engineering Team has conducted a site inspection in December 2023 and confirmed that <u>10 metre</u> 'No Stopping' regulation applies to this intersection. This regulation is currently not signposted.

To improve sight lines at the location it is proposed to install <u>15 metre</u> "No Stopping' restrictions in Edgeworth David Avenue at the intersection with Jubilee Street.

A plan of the proposal is attached.

CONSULTATION

Small increase in the restriction by 5 metres from the regulatory 10 metres does not warrant consultation. Local residents will be notified of the new restrictions.

RECOMMENDATION THAT

1. Two 'No Stopping' signs to be installed on northern side of Edgeworth David Avenue, 15 metres away from intersection with Jubilee Street, be approved as per plan No LTC 04/2024.
