



# Community Strategic Plan Review 2021 Stakeholder Engagement Summary

Several stakeholders have participated in meetings to gather feedback for the review of the Community Strategic Plan (CSP). These meetings have been arranged via different pathways: stakeholders initiated contact with Council in response to the online community survey that was promoted in September and October 2021; Council committees/advisory groups were given the opportunity to participate in a meeting; and some stakeholders were contacted directly due to significant opportunities for partnership in the delivery of the CSP.

The table below outlines the stakeholder meetings held and the key discussion points raised at each meeting. These topics and ideas have been considered and incorporated into the draft CSP.
