# REFERRAL OF TRAFFIC MATTER FOR COMMENT OR OBJECTION, IF ANY

## **SUMMARY**

This report details the traffic implications of the proposed Bus Stop relocations near No 183 Shepherds Drive, 218 Purchase Road and 186 Purchase Road by CDC Bus Company to improve accessibility.

#### **SUBJECT**

Hornsby Council has received a request from CDC Bus Company in relation to relocation of bus stops in Shepherds Drive and Purchase Road, Cherrybrook.

As part of the B-Pole wayfinding upgrade roll-out, CDC Bus Company has undertaken audits of all of their bus stops across the operating region. As part of this, CDC Bus Company has undertaken accessibility assessments at each stop. Recent guidelines issued by Transport for NSW require a clear circulation space of 3140 mm long and 2070 wide at the boarding point at every stop as per Transport's interpretation of the Disability Discrimination Act 1992 (DDA) and Disability Standards for Accessible Public Transport (DSAPT).

This assessment has identified that the following bus stops cannot be made compliant at their current locations and require relocation to achieve sufficient circulation space. Accordingly, CDC Bus Company is proposing minor adjustments to the following stops in order to achieve compliance:

- Stop ID:212643 Shepherds Drive opposite Purchase Road (183 Shepherds Drive) relocate 7 m to the approach side of the driveway at no. 183 Shepherds Drive.
- Stop ID:212644 Purchase Road opposite Naomi Court (218 Purchase Road) relocate 10 m to the approach side of the driveway at no. 218 Purchase Road.
- Stop ID:212646 Purchase Road after Eldridge Street (186 Purchase Road) relocate
   10 m to the approach side of the driveway at no. 186 Purchase Road.

The proposed changes have been kept to the minimum necessary to achieve compliance whilst also minimising impact on residents, parking availability and other road users, and will provide greater certainty to Council when installing accessible boarding points. In addition, these will also allow CDC Bus Company to install new light-blue wayfinding signage at each stop, in cooperation with Transport for NSW.

### **CONSULTATION**

CDC Bus Company has conducted community consultation with nearby residents in July 2021. Residents have been provided with at least 14 calendar days to respond. No objections or submissions were received.

- Relocation of bus stop approximately 7 metres to the approach side of the driveway at no. 183 Shepherds Drive (Stop ID: 212643 - Shepherds Drive opposite Purchase Road) be approved.
- Relocation of bus stop approximately 10 metres to the approach side of the driveway at no. 218 Purchase Road (Stop ID: 212644 - Purchase Road opposite Naomi Court) be approved.
- Relocation of bus stop approximately 10 metres to the approach side of the driveway at no. 186 Purchase Road (Stop ID: 212646 - Purchase Road after Eldridge Street) be approved.
