REFERRAL OF TRAFFIC MATTER FOR COMMENT OR OBJECTION, IF ANY

SUMMARY

This report details proposed changes to the parking restrictions in the Pennant Hills Library and Community Centre offstreet parking area, to allow members of the public to use the staff parking spaces after hours.

SUBJECT

Hirers and customers of the Pennant Hills Community Centre, residents, visitors and customers of Pennant Hills Library, have contacted Council requesting to be allowed public use of the Council staff 'Authorised Parking' spaces in the Pennant Hills Library off-street parking area.

It has been reported that the staff parking spaces are often under-utilised, while visitors are unable to find parking.

Council's Traffic Engineering & Road Safety team has investigated the parking spaces at Pennant Hills Community Centre and Library, concluding that:

- Existing signs for 'Authorised Parking' spaces are inconsistent with Authorised Parking signage guidelines and Council's general practice.
- There appears to be an excess of parking spaces reserved for staff in the area.
- Staff spaces are under-utilised after hours.

Council has developed a proposal to streamline the signage, to bring it in line with other authorised parking signs in Hornsby Shire, where Council staff or Council's contractors can be authorised to use them.

The suggested time of operation of the new zone is 8am to 6pm, which is consistent with other restrictions in the carpark. It is proposed that nine (9) spaces be provided as 'Authorised Parking' spaces in total, a reduction from twelve (12) spaces.

The proposal is for all parking spaces to be available to the general public after 6pm.

The proposal can effectively improve the utilisation of parking spaces in the Pennant Hills Library off-street parking area and benefit members of the public who attend the Community Centre after hours.

A plan of the proposal is attached.

CONSULTATION

Hornsby Library management and staff have been consulted about the proposal and support the changes.

RECOMMENDATION THAT

- 1. Three spaces currently designated as 'Authorised parking' be changed to 3-hour parking restrictions (3P, 8am-6pm Mon-Fri, 8am-12.30pm Sat).
- Nine spaces be signposted as 'No Parking, Hornsby Shire Council Authorised Vehicles Excepted, 8am-6pm'.
- 3. 'No Stopping' restriction be posted in the turning bay.
