REFERRAL OF TRAFFIC MATTER FOR COMMENT OR OBJECTION, IF ANY

SUMMARY

This report details the traffic implications of a proposed temporary 'Works Zone' in **Rupert Street** to accommodate the construction of a Construction of 29 townhouses, with a basement carpark at 487 - 495 Pacific Highway, Asquith.

SUBJECT

Council has received a request from the property owner for a temporary 'Works Zone' at the side boundary of 487 - 495 Pacific Highway, Asquith (Rupert Street). The building works project is in accordance with approved DA/1213/2018 - Construction of 29 townhouses with a basement carpark.

The proposed 25 lineal metres long "Works Zone" is required to accommodate deliveries and construction vehicles during construction which has commenced at the site and is required for a period of 30 weeks initially. Providing the temporary "Works Zone" along the site's Rupert Street boundary will minimise disruption to traffic when construction vehicles require access to the site.

The detail is shown on attached drawing from Optimus Traffic Management.

It is also proposed that 10m "No Stopping" restrictions be posted in Rupert Street near the intersection with Pacific Highway to maintain adequate space for manoeuvring vehicles (reinforcing the existing regulations).

This zone will a permanent installation.

CONSULTATION

Temporary "Works Zone" - No further consultation is required as the location of the proposed 'Works Zone' is along the side boundary of the construction site.

Permanent "No Stopping" Zone - Installation of the "No Stopping" signs will reinforce the existing regulations that apply at this intersection. Local residents will be informed of the installation of signs to reinforce the road rules.

RECOMMENDATION THAT

1. 25m long 'Works Zone 7am-5:00pm, Mon-Sat' be approved for installation at side boundary of 487 - 495 Pacific Highway, (Rupert Street), Asquith for the duration of the construction activity (initially 30 weeks) in accordance with Council's 2023/2024 Fees and Charges.
 2. 10m "No Stopping" restrictions be posted in Rupert Street near the intersection with Pacific Highway
