REFERRAL OF TRAFFIC MATTER FOR COMMENT OR OBJECTION, IF ANY

SUMMARY

This report outlines the results of an investigation into the installation of a Pedestrian (Zebra) crossing at the existing pedestrian refuge in Peats Ferry Road near Citrus Avenue.

SUBJECT

Council has received a request from Asquith Boys High School to upgrade the existing pedestrian refuge to a marked pedestrian crossing. The school has also requested Roads and Maritime Services (RMS) to extend the existing School Zone to the south along Peats Ferry Road to include the pedestrian refuge islands. The extension of the School Zone was completed by RMS in late 2017.

Pedestrian counts and a traffic study were undertaken at the existing refuge in March 2017. The pedestrian and vehicular count results are as follows:

RMS Warrants

The Roads and Maritime Services (RMS) guidelines for traffic facilities contain a number of warrants which need to be met. These warrants are based on some of the following:

P – Measured pedestrian flow per hour

V – Measured vehicular traffic flow per hour

Type of road 85th percentile speed Sight distance Crash History

The RMS warrant for a marked foot crossing is the product of P and V, which must equal or exceed a value of 60,000 during three separate periods in a day. This crossing did not meet the warrant for a standard operational marked foot crossing due to low pedestrian activity during the midday peak.

However, a reduced warrant for school children requires that in two periods of one hour duration immediately before and after school hours, P must be equal to or greater than 30 (where the crossing is predominantly used by school children) and V must be equal to or greater than 200.

Pedestrian count data at this location indicates that the site does meet the RMS reduced warrant for a pedestrian (Zebra) crossing that will be predominantly used by school children.

Site observations

- The existing pedestrian refuge island at the location provides a road narrowing and acts as speed reduction at the crossing location.
- The recently extended school zone makes it an appropriate location for a marked crossing predominantly used by students.
- The current "No Stopping" parking restrictions are appropriate for a full time crossing, hence there will be no impact on parking.
- Residents from nearby residential flats (some still under construction) will benefit from the marked crossing.

CONSULTATION

In December 2017 Council invited comments on the proposal from residents, and the school. The proposal was also placed on Council's website. Letters were sent to regulatory authorities and transport providers.

No submissions were received by Council.

CONCLUSION

Provision of a pedestrian crossing at this location will improve safety of high school students and other users. The existing pedestrian refuge with kerb ramps is suitable for conversion to a pedestrian crossing with the addition of zebra bars. Pedestrian crossing regulatory signage will be installed in accordance with attached drawing number LTC 10/2018.

RECOMMENDATION THAT

- 1. The existing pedestrian refuge in Peats Ferry Road near Citrus Avenue, Hornsby be upgraded to a full time pedestrian (Zebra) crossing.
- 2. Crossing regulatory signs and road markings be installed as per attached drawing No. LTC 10/2018.
