REFERRAL OF TRAFFIC MATTER FOR COMMENT OR OBJECTION, IF ANY

SUMMARY

This report details the traffic and parking implications of proposed amendments of existing parking restrictions along New Line Road and existing 'Bus Zone' operational hours in Cherrybrook Public School, Cherrybrook.

SUBJECT

Council has received a request from Cherrybrook Public School to amend existing parking restrictions and 'Bus Zone' in New Line Road along the school frontage to improve traffic flow during the school AM and PM peak periods.

Cherrybrook Public School is currently operating a staggered pickup/drop off operation on the private road of the school. However, the operation is conflicting with the existing hours of operation for the 'Bus Zone' causing confusion for parents and staff. The proposed amendments will formalise the continuation of the school bus service till 3pm and commence the staggered pickup/drop off operation from 3pm to 4pm.

The amendments to the existing 'Bus Zone' and 'No Parking' restrictions will not impact on parking, as parking is currently prohibited during the school AM and PM peak.

It is proposed that:

- 1. 22 metre long 'Bus Zone, 8am-9am 2.30pm-3.30pm, School Days' and the 34 metre long 'Bus Zone, 2.30pm-3.30pm, School Days' be amended to 'Bus Zone, 2.30pm-3pm, School Days' along the western side of the private road in Cherrybrook Public School.
- 2. 34 metre long 'No Parking, 8am-9am, 'School Days' be extended and amended to 'No Parking, 8am-9.30am 3pm-4pm, School Days' along the western side of the private road in Cherrybrook Public School.
- 3. 57 metre long 'No Parking' be amended to 'No Stopping' along the eastern side of the private road in Cherrybrook Public School.
- 4. 72 metre long 'No Parking, 2.45pm-3.15pm, School Days' be amended to 'No Parking, 2.30pm-4pm, School Days' along the western side of New Line Road, south of the southern driveway of Cherrybrook Public School.
- 5. 103 metre long 'No Parking, 8am-9am 2.30pm-3.30pm, School Days' to be amended to 'No Parking, 8am-9.30am 2.30pm-4pm, School Days' along the eastern side of New Line Road.

A plan of the proposed parking restrictions amendments is attached to this report.

CONSULTATION

In March 2018, Council officers attended an onsite meeting with the principal of Cherrybrook Public School discussing traffic and parking issues during the school AM and PM peak periods. Following development of the proposal, the principal has sent letters to Council and CDC Hillsbus supporting the changes.

Public consultation for the changes to parking restrictions in New Line Road near Cherrybrook Public School is not required as they do not result in any loss of parking.
