REFERRAL OF TRAFFIC MATTER FOR COMMENT OR OBJECTION, IF ANY

#### **SUMMARY**

This report details the proposed installation of "Stop" sign and associated line marking in Bevans Road at the intersection with Crosslands Road, Galston.

### **SUBJECT**

Council has received a request from local resident to install a "Stop" sign at the subject intersection. The resident reported that vehicles entering Crosslands Road from Bevans Road often fail to give way to vehicles proceeding along Crosslands Road.

The intersection of Crosslands Road and Bevans Road currently operates under the T intersection rule without any signage or delineation. An advisory T- intersection sign is posted on the approach to the T in Bevans Road. Site observations indicate that sight distance to the west (looking from Bevans Road) is affected by the crest of the hill and curve on Crosslands Road.

This proposal is the installation of "Stop" sign (R1-1) and associated linemarking at the intersection of Bevans Road and Crosslands Road.

# **CONCLUSION**

The subject intersection's SISD (safe intersection sight distance) is deficient as it is affected by crest and curve in the road. As altering the geometry of the road is not economically feasible, it is considered appropriate to upgrade the existing unsigned give-way priority with formal 'Stop' sign and delineation as shown on the attached plan.

# RECOMMENDATION THAT

1. The installation of "Stop" sign (R1-1) and associated linemarking on Bevans Road at the intersection of Crosslands Road, Galston be approved.
