# REFERRAL OF TRAFFIC MATTER FOR COMMENT OR OBJECTION, IF ANY

# **SUMMARY**

This report details the proposed parking restrictions to improve bus access and turn-around area in Dangar Road, Brooklyn.

# SUBJECT

Council has received a request to install parking restrictions in the bus turn-around area at 10 Dangar Road, Brooklyn, from the local bus operator TransDev.

Dangar Road is used by public buses and private coaches to set-down and pick-up passengers at the Hawkesbury River Railway Station.

While due to site constraints there is no formal bus turn-around area, bus drivers use the driveway to the Arts Cottage Centre to make a 3-point turn at this location, to return to Brooklyn Road.

It has been reported that cars often park illegally in the driveway, which makes turning for buses difficult.

While parking in the driveway is illegal, the alignment and appearance of the area is similar to a parking spot and often attracts illegal parking.

The informal looking driveway was specifically designed to match other heritage features of the area.

A plan showing the proposal is attached.

#### CONSULTATION

Council's Strategy & Place Branch has consulted with the Brooklyn Community Association (BCA) which supports the proposed parking restrictions. Broader consultation is not required as the proposed restrictions do not impact on the general public.

Parking in a driveway in a way that blocks access to a property is illegal.

#### **CONCLUSION**

The proposed parking restrictions will ensure that buses can safely turn around in Dangar Road.

A future dedicated turn-around area for the buses is being considered as part of the Brooklyn planning process.

# **RECOMMENDATION THAT**

1. Installation of 'No Stopping' restrictions in the driveway at No 10 Dangar Road, Brooklyn be approved.
