REFERRAL OF TRAFFIC MATTER FOR COMMENT OR OBJECTION, IF ANY

SUMMARY

This report details the parking implications for the proposed 2 hour parking restriction along the eastern side of Palmerston Road, south of Northcote Road to provide additional short term parking for patients and visitors of Hornsby Ku-ring-gai Hospital.

SUBJECT

NSW Health Infrastructure is currently constructing a six level multi-deck car park building containing 523 car parking spaces for Hornsby Ku-ring-gai Hospital. As part of the development works, reconstruction of the kerb along the eastern side of Palmerston Road south of Northcote Road will commence after the completion of the multi-deck car park. Richard Crookes Construction has submitted a signage plan for the proposed reconstructed kerb alignment, allowing additional short term parking on Palmerston Road. The purpose of the restriction is to improve availability of short term parking for visitors and residents to enable short term access to nearby services in and around Palmerston Road.

It is proposed that an 18m long section of 2 hour parking restriction be provided along the eastern side of Palmerston Road, south of Northcote Road. The parking restriction being considered involves the establishment of approximately 3 parking spaces with a 2P 8.30am – 6.00pm Mon – Fri and 8.30am – 12.30pm Sat parking restriction. This area is currently posted as a "No Stopping" zone.

A plan of the proposed parking restrictions is attached.

PUBLIC CONSULTATION

The development application for the construction of a six level multi-deck car park building for Hornsby Ku-ring-gai Hospital (DA/129/2017) was subject to Council's planning notification process. No further consultation is required as the location of the proposed parking restrictions is along the frontage of the hospital.

RECOMMENDATION THAT

- 1. 18m long section of 2P 8.30am 6.00pm Mon Fri and 8.30am 12.30pm Sat restriction be provided along the eastern side of Palmerston Road, south of Northcote Road, Hornsby.
- 2. "NO STOPPING" be installed along the hospital frontage at the intersection of Palmerston Road and Northcote Road, Hornsby.
