REFERRAL OF TRAFFIC MATTER FOR COMMENT OR OBJECTION, IF ANY

SUMMARY

This report details the traffic implications of proposed temporary 'Works Zone' and changes to existing 'No Stopping' restrictions in Clarke Road, Hornsby, to accommodate the construction of a demolition of basketball and tennis courts and construction of an educational establishment and childcare centre at Barker College.

SUBJECT

Council has received a request from Structure Australia Pty Ltd for a temporary 'Works Zone' in Clarke Road, Hornsby. The building works are in accordance with an approved development of community facility and redevelopment of prep school at Barker College (DA/1194/2016/B).

Proposed temporary Works Zone

The proposed 24 metre long 'Works Zone' along the northern side of Clarke Road is required to accommodate deliveries and construction vehicles during construction which has commenced at the site and is required for a period of 35 weeks initially. Providing the temporary 'Works Zone' along the site's frontage will minimise disruption to traffic when construction vehicles require access to the site.

Proposed permanent changes to existing 'No Stopping' restrictions

Council has received requests from residents concerned with cars parking along both sides of Clarke Road on weekends and after hours which restricts traffic flow to a single lane. Clarke Road is 8 metres wide and when vehicles are parked along both sides of the road the usable carriage width is limited to approximately 4 metres which is insufficient to maintain two-way traffic flow.

It is proposed that the existing 'No Stopping (8am-9.30am, 2.30pm-4pm, School Days, 8am-12.30pm Sat) Zone' located along southern side of Clarke Road, between Unwin Road and Marillian Avenue be permanently changed to full time 'No Stopping' restrictions. This change is required to maintain uninterrupted two-way traffic flow during the construction period and to cater for future increased traffic generated by the Barker College.

CONSULTATION

No consultation is required as the location of the proposed 'Works Zone' and 'No Stopping' restrictions are along the frontage Barker College and properties owned by Barker College.

RECOMMENDATION

- 1. 24 metre long 'Works Zone 7am-5:00pm, Mon-Sat' be approved for installation along the northern side of Clarke Road, Hornsby for the duration of the construction activity (initially 35 weeks) in accordance with Council's 2019/2020 Fees and Charges.
- The existing 'No Stopping (8am-9.30am, 2.30pm-4pm, School Days, 8am-12.30pm Sat) Zone' located along southern side of Clarke Road, between Unwin Road and Marillian Avenue be permanently changed to full time 'No Stopping' restrictions.
