# REFERRAL OF TRAFFIC MATTER FOR COMMENT OR OBJECTION, IF ANY

### **SUMMARY**

This report details the traffic implications of proposed changes to existing parking restrictions in Kirkpatrick Way, Berowra Waters, at the Rural Fire Brigade.

## SUBJECT

Council has been requested by the **Berowra Waters Rural Fire Brigade** (RFB) to change the existing parking restrictions in Kirkpatrick Way to accommodate other **designated vehicles**. This to allow better management of parking for the RFB in this high parking demand area.

The existing parking restrictions at this location are 'No Parking - Emergency Vehicles Excepted', approximately 18 metres long. These restrictions were approved by the Hornsby Local Traffic Committee in 2007. (LTC 12/2007 - Trim D00651307) The current restrictions do not accommodate other **operational vehicles** associated with the RFB.

It is proposed that the restrictions be changed to

'No Parking - Hornsby Shire Council Authorised Vehicles Excepted'

and that the authority for parking in the zone be managed by Council staff in consultation with RFB.

### **CONSULTATION**

The proposed parking restrictions are in the same area as the existing restricted area already designated for the RFB.

There will be no impact on parking to the general public. Further consultation is not warranted.

### **RECOMMENDATION THAT**

 'No Parking - Hornsby Shire Council Authorised Vehicles Excepted' (18 metres) be posted in Kirkpatrick Way at the Rural Fire Brigade and that the existing 'No Parking - Emergency Vehicles Excepted' signs be removed.
