## **SUMMARY**

This report details the traffic implications of proposed temporary 'Works Zone' at No 77 Balmoral Street, Waitara, to accommodate the construction of a dwelling house. (Approved DA 857/2020)

**SUBJECT** 

Council has received a request from Rawson Homes Pty Ltd for a temporary 'Works Zone' at the front boundary of 77 Balmoral Street, Waitara. The building works project is in accordance with approved development application (DA/857/2020). The proposed 11 metres long 'Works Zone' is required to accommodate deliveries and construction vehicles during construction which has commenced at the site and is required for a period of 42 weeks initially. Providing the temporary 'Works Zone' along the site's frontages will minimise disruption to traffic when construction vehicles require access to the site.

**CONSULTATION** 

No further consultation is required as the location of the proposed 'Works Zone' is along the frontage of the construction site.

**RECOMMENDATION THAT** 

1. 11m long "Works Zone 7am-5:00pm, Mon-Sat" be approved for installation at 77 Balmoral Street, Waitara for the duration of the construction activity (initially 42 weeks) in accordance with Council's 2020/2021 Fees and Charges.
