These should be adequate to obstruct / prevent vehicles from parking within 10m of the T intersection, on the Mark Place side (the other side of Beechwood Parade is continuous and does not cause much if any concern). The main reason for this is to improve visibility at Mark Place / Beechwood Parade, and therefore safety overall. I do not believe signage alone will result in the required safety improvements. The island barriers do not need to extend further into Beechwood Parade than necessary, only far enough into the roadway to eliminate the danger of cars parking too close to the intersection. Island barriers would enable the installation of signage on them, to slow traffic approaching the nearby Purchase Rd / Beechwood round about. This should further improve pedestrian safety. As the concrete footpath on Beechwood Parade extends from our lawn to the kerb, there is not space for signage unless added to new islands that force parking compliance. Signage and possibly other traffic calming measures as appropriate, but not to obstruct the footpath on Beechwood Parade.	Beechwood Parade / Mark Place intersection - Council does not install physical barriers to enforce illegal parking near intersections. The road rules regulate parking near intersection within 10m. Traffic rangers will monitor the location for illegal parking. No speed humps are proposed at the present time in Beechwood Avenue. A review of the crash data indicates that the roundabout is operating safely with no crashes recorded in over 10 years.
